Mission Statement

The Department of Music at The College of New Jersey promotes music study in a program where performance, music education, technology, creativity, and scholarship are closely integrated. Our core curriculum emphasizes comprehensive performance opportunities, rigorous academic inquiry, and professional certification. Our programs offer a range of music curricula, including individualized and innovative interdisciplinary options.

Background of the Department

The Department of Music has been a center for the study of music since 1918. Its graduates not only enjoy an excellent placement record for employment and graduate school, but they also consistently attain leadership positions in the varied fields of musical endeavor. The College of New Jersey is an accredited institutional member of the National Association of Schools of Music (NASM). The Department offers various programs of musical study which are consistent with the high standards, ideals, and philosophy of this organization.

The Department of Music, with its large roster of artist-teachers and -scholars, offers diverse types of private studio and musical ensemble experience, inspiring academics, state-of-the-art equipment, and strong library holdings. In addition, its varied curricula provide a wide selection of courses designed as academic, artistic, and professional preparation for work in a variety of music careers. The College has a state-of-the-art music building that serves as the primary facility for concerts and recitals. The Music Building contains the 300+ seat Mildred and Ernest E. Mayo Concert Hall, critically acclaimed for its aesthetic and acoustical properties, as well as instrumental and choral rehearsal halls, a keyboard laboratory, numerous classrooms, small ensemble suites, and practice rooms. There is also a recording studio and a computer and synthesizer lab located in the adjacent Art and Interactive Multimedia Building.

Requirements for All Music Majors:

All students must audition for entrance into the Department of Music and when requesting a change in major applied area (primary instrument) or degree program.

- All music majors must pass the required Sophomore Review.
- All Music Education and Performance majors must present a senior recital in their primary performance area. Before beginning to prepare for the senior recital, all students must pass a junior hearing in front of representative faculty from their primary applied area. Performance majors must present a sophomore and junior recital, in addition to the senior recital. Students must register for applied study and the recital course during the semester of their recital performance(s).
- Every recital presented must have a recital hearing one month before the event. Only the successful completion of the hearing will ensure a recital

performance.

- All music majors must pass a Keyboard Proficiency Exam as a requirement for graduation. Music Education students must pass the Keyboard Proficiency Exam by the end of their junior year to be eligible for Student Teaching.
- Upon the recommendation of the major applied instructor, every music major who is registered for private studio at the 300 level or higher will perform in the Tuesday afternoon student recital series at least one time each academic year.
- All Performance and Music Education majors must enroll in a large ensemble each semester in which they are registered as full-time students and successfully complete the course with a grade of C- or higher. This requirement is waived only during the semester in which a Music Education student is Student Teaching. Part-time students (those taking fewer than three course units of study per semester) must petition the departmental Performance Affairs Committee for a special exemption from primary ensemble participation on a semester-by-semester basis.

Private Lessons

Music Majors: Private lesson requirements vary by music degree program; please see specific program requirements below. All music majors taking private applied lessons must perform once each academic year in the Department's Tuesday Recital Series, and they must complete a performance jury for each semester of enrollment in lessons in order to receive credit.

Non-music majors: Note: Applied Studio (Private) Lessons at the intermediate (200s) or advanced (300s) levels require a qualifying audition before the initial registration. Beginner level lessons are not available for collegiate credited studies. There is a per-credit tuition fee for the Applied Studio (Private) Lessons (\$500.00/semester at the 200-level, \$1,000.00/semester at the 300-level).

Program Entrance, Retention, and Exit Standards

Every degree program at the College has set standards for allowing students to remain in that program, to transfer within the College from one program to another, and to graduate from a program. The following are the standards for Department of Music programs:

- 1. Retention in music programs is based on the following standards in these content areas:
 - a. *Applied Study.* The lowest passing grade for studio lessons for Performance Majors (400 level lessons) is B-. The lowest passing grade for studio lessons for 200 and 300 level lessons is C-.
 - b. *Teacher Preparation*. Music Education majors must achieve a grade of C+ or above in the following teacher preparation courses: MUS 241, MUS 392, MUS 394, MUS 397/398, and MUS 492. Music Education majors must also achieve a minimum passing grade of B- in MUS 490, "Student Teaching."
 - c. *All other Music Courses*. A grade of C- is the minimum passing grade for all other courses taken toward completion of programs in music.

- 2. Additionally, retention in the B.A. in Music and B.M. in Performance degree programs requires a minimum cumulative GPA of 2.0 for every semester. Retention in the B.M. in Music Education requires a minimum cumulative GPA of 2.5 at the end of the first and second semesters, 2.75 at the end of the fourth semester, and 3.0 when applying for and participating in Student Teaching.
- 3. Transfer into the Department of Music from another program within the College is based upon satisfactory completion of an audition process, including a performance audition and degree program interview.
- 4. Music majors may be put on departmental probation or dismissed from their degree program for any one, or a combination, of the following reasons: low GPA (below required standards), failure to progress toward a degree, unacceptable or failing result on the Sophomore Review, and/or failing to meet expectations for TCNJ's School of Education *Educator Disposition Assessment* (EDA, for Music Education). Duration of the probation period will be determined on a case-by-case basis by the Department of Music Academic Affairs Committee after a mandatory conference with the student.

Bachelor of Arts: Music

The Bachelor of Arts in Music degree (B.A. in Music) includes a core of intensive music study: Musicianship (music theory and aural skills), Historical and Cultural Studies in Music, and an array of Music Electives (including, but not limited to, private studio, large and small ensemble performance, Music Technology). At the same time, the B.A. degree emphasizes the study of music in the context of TCNJ's competitive Liberal Arts experience. In addition to fulfilling the College Core requirements for all TCNJ students, B.A. in Music students plan a course of Free Electives and are mentored by their advisor to pursue interdisciplinary academic and creative perspectives on music. Secondary majors, minors, and/or concentrations are also possible, and encouraged, as is study abroad. Ultimately, the B.A. in Music degree prepares students for a diverse range of careers depending on their individualized courses of study. Applicants for the B.A. in Music degree must demonstrate that they possess the skills to participate successfully in a curricular ensemble, and in an applied studio at least at the intermediate (200) level, as determined through auditions with the applicable area coordinator and ensemble director.

The precise sequence of courses will be determined through individualized advisement.

Bachelor of Music: Music Education

The Bachelor of Music in Music Education prepares students to be certified public school teachers. There are three tracks in this degree: Instrumental (Wind, Strings, and Percussion), Keyboard, and Vocal. (Keyboard, Guitar, and Harp have either a vocal or instrumental emphasis in determining large ensemble requirements.) Successful completion of the degree qualifies students to sit for the Music Content Knowledge Praxis Examination prior to student teaching. Graduates of this program may also qualify for certification in other states, subject to the individual processes of each state. The Bachelor of Music in Music Education degree is constructed on a solid core of performance experiences and, as such, also prepares students for potential graduate study. Certification qualifies students to teach K-12 music in the New Jersey Public Schools.

Teacher Preparation Requirements

- 1) A cumulative grade point average (GPA) of at least 3.0 is required for students to complete the Music Education program successfully and be recommended for certification and licensure. To help assure that students at The College of New Jersey meet this requirement by graduation, the following procedures will be strictly followed:
 - (a) Admission to full candidacy (junior-level courses and above) in the Music Education program may be awarded following the successful completion of the Sophomore Review, Keyboard Proficiency, TCNJ's School of *Education Educator Disposition Assessment* (EDA), and a 2.75 minimum cumulative GPA. Students with a cumulative GPA below 2.75 at the end of their fourth semester will be placed on Academic Probation and will not be permitted to continue with teacher education courses until the cumulative GPA is raised to 2.75 and may be dismissed from the program for failure to progress.
 - (b) Admission to upper-level courses, MUS 392 and MUS 397/398, requires a 2.75 minimum cumulative GPA. In addition, admission to MUS 397/398 requires successful completion of MUS 340 or 380. When applying for and participating in student teaching, a student must have successfully completed MUS 330 and MUS 452, and attained a 3.0 minimum cumulative GPA. In order to apply for state teaching certification through The College of New Jersey, students must have a 3.0 cumulative GPA at the time of program completion.
- 2) Students also must meet the state hygiene/physiology requirement; the state Harassment, Intimidation, and Bullying Prevention (HIB) training certificate requirement; and Music Content Knowledge PRAXIS before the New Jersey State Department of Education will issue the appropriate certificate. Teacher Education candidates will receive a "certificate of eligibility with advanced standing" which requires a candidate to be provisionally certified for his or her first year of teaching. After one year of successful teaching, the candidate is eligible for a permanent certificate. Note that State certification requirements are often in flux. The music education degree program will immediately adapt to any state mandates that are issued within a given academic year.
- 3) A Mantoux, or tuberculosis test is required by the state of all students prior to the first day of student teaching. This test can be obtained through The College of New Jersey Health Center.
- 4) Because of the number of concentration specializations that can be pursued in this major, only the core courses of a student's program of study are set out below. Students should consult with their departmental academic advisors in planning the remainder of their academic program. These plans should take into account requirements for the major, College Core, professional courses, and state certification.
- 5) All Music Education students are required to take SPE 203 or ELE 201 in order to meet requirements of the New Jersey State Department of Education.

Music Minor

The Music Minor requires **a total of five course units**, taken from the lists below in consultation with the assigned Department of Music advisor. Students are encouraged to start the Music Minor in the second semester of their freshman year and must start no later than the first semester of their second year. There is no performance audition required to declare the Music Minor.

1 course unit of Musicianship: MUS 261/Musicianship I (Fall). Alternatively, MUS 262/Musicianship II (Spring), MUS 263/Musicianship III (Fall), or MUS 264/Musicianship IV (Spring) may be taken depending upon placement assessment.

2 course units of Historical and Cultural Studies in Music, Music Technology, College Core courses in Music, and/or additional music courses.

0.5 course units of Applied (200- or 300-level) Studio (Private) or Class Lessons:

Note: Applied Studio (Private) Lessons at the intermediate (200s) or advanced (300s) levels require a qualifying audition before the initial registration. Beginner level lessons are not available for collegiate credited studies. There is a per-credit tuition fee for the Applied Studio (Private) Lessons (\$500.00/semester at the 200-level, \$1,000.00/semester at the 300-level). Class Lessons include MUS 102 (Beginning Class Piano), 103 (Beginning Class Piano II), and 228 (intermediate class guitar).

- A minimum of one course unit at the 300-level (or above) is required.

Theatre Minor

Housed in the Department of Music, TCNJ's Theatre Minor provides students with immersive creative experiences in theater, including musical theatre, enhanced by course options in technical and literary aspects of theatre. An audition is not required to enter the Theatre Minor.

Students are encouraged to start the Theatre Minor no later than the first semester of their second year. Students will be assigned a Department of Music advisor and must consult with their advisor in the selection of courses.

Music Performance Minor (for Music Education Majors only)

The Music Performance Minor is only open to matriculated music education majors. Music education majors must apply during the same semester of their sophomore review and will complete a music-performance minor audition for a faculty committee. To be accepted into the music performance minor, applicants must demonstrate performance level commensurate with a second-year performance-major. In addition, to be eligible to apply for the minor, students must have a minimum cumulative GPA of 3.3 at the end of the sophomore year (or the semester sophomore review is completed), and have successfully completed select required core courses including: Musicianship III, Keyboard Skills II, Music from 1750-1945, and Introduction to Music Education.

The Music Performance minor requires a total of five course units, taken from the list below in consultation with the assigned Department of Music advisor. Students may begin working towards requirements their first year (e.g. secondary ensembles), but cannot declare the minor until completion of a successful application/audition as outlined above.
